The Electric Business Prescriptive Program provides rebates for common energy-efficient equipment installs and upgrades at your business facility.

Eligibility

CenterPoint Energy commercial and industrial customers that receive electric service are eligible for rebates, unless they have opted out of energy efficiency programs. All installations must be new equipment. **Terms and conditions apply.**

Applications for rebates in excess of \$20,000 per facility per year MUST be pre-approved by CenterPoint prior to purchasing or installing equipment. See the Business Prescriptive Program Application for more details.

Examples of qualifying electric projects

Here are some examples of common energy-saving projects that may qualify for a Business Prescriptive Program rebate at smaller facilities, such as schools, offices, auditoriums, warehouses, retail locations and grocery stores.

- **Heating and cooling:** Air conditioners, Variable Frequency Drives (VFDs), heat pumps, chillers and advanced rooftop controls
- **Lighting:** LEDs, occupancy sensors, refrigerated case lighting and lighting controls
- **Commercial kitchen:** Refrigerators, freezers, commercial ice machines, dishwashers and cooking equipment
- **Agriculture:** Dairy plate coolers, high-speed fans and livestock waterers
- **Miscellaneous:** Clothes washers, barrel wrap insulation, variable speed air compressors and compressed air leak study

How the program works

Pre-installation

- Identify a possible energy-efficiency project at your facility.
- Visit [CenterPointEnergy.com/INBusinessRebates](https://www.CenterPointEnergy.com/INBusinessRebates) to view a complete list of qualifying electric projects and the available rebates.
- Get program pre-approval by CenterPoint prior to purchasing or installing equipment for incentives over \$20,000.

Installation

- Purchase and install your energy-saving equipment.
- Download and complete a Business Prescriptive Program application.
- Download and complete the measure selection form(s) associated with the rebate(s) you are applying for.

Post-installation

- Submit your completed application along with the measure selection form(s), technical data sheets and copies of all equipment and services invoices within 90 days of project completion.
- After a project review is complete and your rebate is approved, you will receive a rebate check in the mail.

Energy-saving project snapshots

George Koch Sons LLC - lighting retrofit

- Measures implemented: Compressed air leak study and repair
- Measures implemented: Interior and exterior lighting
- Total project cost: \$44,275
- Estimated annual energy savings: 162,395 kWh
- Estimated annual cost savings: \$24,771
- Rebate: \$23,575
- Estimated payback period without rebate: 1.8 years
- Estimated payback period with rebate: .8 years

Diversity Vuteq LLC - compressed air project

- Measures implemented: Compressed air leak study and repair
- Total project cost: \$757
- Estimated annual energy savings: 159,232 kWh
- Estimated annual cost savings: \$12,947
- Rebate: \$757
- Estimated payback period without rebate: .1 years
- Estimated payback period with rebate: immediate
