VERIFIED JOINT PETITION TO MODIFY SERVICE AREA BOUNDARIES

Western Indiana Energy Rural Electric Membership Corporation ("WIN Energy") and Southern Indiana Gas & Electric Company d/b/a CenterPoint Energy Indiana South ("CEI South") (together "Joint Petitioners"), jointly petition the Indiana Utility Regulatory Commission ("IURC" or "Commission") to approve their Agreement to modify portions of their assigned service area boundaries located on U.S.G.S. Facet Map D-29 in Gibson County, Indiana, and state in support thereof:

- 1. Joint Petitioner, WIN Energy, is a Rural Electric Membership Corporation organized and existing under the laws of the State of Indiana, with its principal place of business located in Vincennes, Indiana. It is engaged in the business of distributing, furnishing and selling retail electric service to the public in parts of Clay, Gibson, Greene, Knox, Pike, Posey, Sullivan and Vigo counties and has the charter authority to do so.
- 2. Joint Petitioner, CEI South, is a Corporation organized and existing under the laws of the State of Indiana, with its principal place of business located in Evansville, Indiana. It is engaged in the business of distributing, furnishing and selling retail electric service to the public within its service territory, including parts of Gibson County and has the charter authority to do so.

3. Each Joint Petitioner is an "electricity supplier" as such term is defined by Ind. Code

§8-1-2.3-2(b) and the provisions of Ind. Code §8-1-2.3-1 et seq. are deemed applicable to the subject

matter of this Joint Petition. The Commission has jurisdiction over the Joint Petitioners and the

subject matter of this proceeding.

4. Pursuant to the Commission's December 21, 1983 Final Order ("Final Order") in

Cause No. 36299-S237(X), the Commission established boundary lines between the Joint Petitioners

on U.S.G.S. Facet Map D-29.

5. Since that time, the Joint Petitioners have agreed that a certain service territory

modification between WIN Energy and CEI South has become necessary. The Joint Petitioners'

proposed modification is shown on U.S.G.S. Facet Map D-29, attached as Exhibit "A" hereto (the

"Proposed Area"). There is one area on Exhibit "A" which Joint Petitioners have agreed will

become part of WIN Energy's service territory. This area is already interconnected to WIN

Energy's system by distribution lines that are owned by WIN Energy.

6. The proposed modification as requested herein will not cause duplication of

facilities, cause a waste of materials or resources, or cause uneconomic, inefficient or inadequate

electric service to the public, consistent with Ind. Code $\S 8-1-2.3-6(a)(2)$.

7. The Commission has jurisdiction of this action pursuant to Ind. Code §8-1-2.3-

6(a)(2).

- 10. In accordance with amended Ind. Code §8-1-2.3-6(2), Joint Petitioners will publish notice of these changes in a newspaper of general circulation in Gibson County, Indiana. Joint Petitioners will file with the Commission the proof of publication of Notice as well as a proposed order promptly following publication. See Exhibit "B" for a copy of the Notice. Further, joint petitioners will post the notice on their respective websites in accordance with 170 IAC 1-1.1-9.
- 11. The technical representative for WIN Energy is Chris Claybrooks, who can be reached at chrisc@winenergyremc.com and by phone at (800)-882-5140 and the technical representative for CEI South is Stephen Rawlinson, who can be reached at steve.rawlinson@centerpointenergy.com and by phone at (812) 491-4507.
- 12. The Parties agree to work with the Commission staff to update the Commission GIS maps, in accordance with any approval of boundary changes.
- 13. This change in service boundaries will result in CEI South losing limited service territory and WIN Energy gaining this service territory. The requested boundary change in the Proposed Area is necessary because a new customer requires service, and Joint Petitioners agree that it would be more cost effective for Win Energy to serve that customer.
- 14. Also pursuant to 170 IAC 1-1.1-9, Joint Petitioners hereby provide notice to this Commission that the parties reasonably anticipated to participate in this proceeding, WIN Energy REMC, CEI South, and the Office of Utility Consumer Counselor ("OUCC"), are in agreement with the following proposed procedural schedule:

October 28, 2021: Joint Petitioners will file their petition with the Commission.

November 4, 2021: (A week following the filing of the petition) the latest date by which

the Joint Petitioners will publish legal notice of the service territory boundary changes in a newspaper of general circulation in Gibson County, Indiana. See exhibit "B" for a copy of the legal notice.

November 24, 2021: twenty (20) days after publication of the legal notice: Joint

Petitioners will file their Submittal of Proposed Form of Order and Proof of Publication. If after publication of the legal notice and twenty (20) days have passed and no affected electricity customer has

requested a hearing, Joint Petitioners advise they waive any

evidentiary hearing concerning this petition.

November 29, 2021: three (3) business days following the immediately preceding deadline

is the last date on which the OUCC may file its testimony and exhibits (if any) opposing &/or objecting to the relief requested by Joint Petitioners and (if applicable) requesting an evidentiary hearing

in this cause of action.

December 22, 2021: The end target date by which the parties request the issuance of the

Commission's final Order concerning this petition.

WHEREFORE, Joint Petitioners, Western Indiana Energy Rural Electric Membership Corporation and Southern Indiana Gas & Electric Company d/b/a CenterPoint Energy Indiana South respectfully request that the Commission, pursuant to Ind. Code §8-1-2.3-6(a)(2), after twenty (20) days and if no affected electricity customer requests a hearing, enter an Order in this proceeding, without a hearing, permanently approving the changes to the service area boundaries on U.S.G.S. Facet Map D-29, as proposed in this Joint Petition.




